

WARWICK RACECOURSE FASHIONS-ON-THE-FIELD TERMS AND CONDITIONS

The Fashions-On-The-Fields Competition on Saturday 11th May is comprised of three categories:

- Best Dressed Individual
- Best Dressed Couple
- Best Hat

On entering, please specify the category you wish to be entered into. You are not limited to entering multiple categories but, please be aware any entrant can only win one prize in total from any one of the categories.

1. By entering the Warwick Racecourse Fashions-On-The-Field Competition on Saturday 11th May 2019 the terms and conditions (as defined below), entrants agree to be bound by these Rules and your attention is specifically drawn to the conditions No. 9, No.12 and No. 17.
2. In the event of any dispute regarding the Rules, conduct, results and all other matters relating to the Warwick Racecourse Fashions-On-The-Field Competition, the decision of Warwick Racecourse shall be final and no correspondence or discussion shall be entered into.
3. The address you provide with your competition entry ("Entry") may be used to send any prizes so please make sure this is correct and you must be aged 18 years or over for the Best Dressed Individual and Best Hat and 25+yrs for Best Dressed Couple and must hold a full British Driving Licence with less than 6 points (due to the nature of the prize).
4. Employees of Warwick Racecourse or any associated company of Warwick Racecourse and their immediate families, persons connected with the competition i.e. prize sponsors, newsagents, wholesalers & their agents are not able to enter the Fashions-On-The-Field Competition
5. By entering the Competition, you hereby warrant that all information submitted by you is true, current and complete. Warwick Racecourse reserves the right to verify the eligibility of all entrants.
6. Warwick Racecourse reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of the Rules.
7. Only one entry per person per Competition is allowed, any entrant who enters more than the permitted maximum will be disqualified.
8. Where the winner/second/third place of the Fashions-On-The-Field Competition has been selected and Warwick Racecourse discovers or has reasonable grounds to believe the winner/second/third is in breach of the Rules, Warwick Racecourse reserves the right to select an alternative winner.
9. Entries to Warwick Racecourse Fashions-On-The-Field Competition must be made by 18.30 on the night of 11th May. Failure to do so will make the entry invalid. To enter you must go to the Fashions-on-the-Field Competition Zone on Ladies Night, fill out an entry form, receive a number and, when this number is called, present your outfit to the judges by walking up and down the designated 'catwalk' area.
10. A ticket is required to enter the Racecourse. There is no purchase requirement to enter the Fashions-On-The-Field Competition.
11. Entrants should note that unless stated otherwise, Warwick Racecourse does not accept responsibility for the return of any Entries, including those consisting of artistic or other material.
12. All prize winners will be notified on the day of the competition, Saturday 11th May 2019, by way of a phone call or SMS message as well as announcements on the racecourse PA.
13. The winners will be decided by our independent panel of judges for people who have entered of their own free will. The independent judges will be announced on the day.

14. There will be three prizes awarded for the Best Dressed Individual (1st-3rd) and prizes for the winners only in Best Hat and Best Dressed Couple. Any entrant can only win one prize in total across any one of the categories.

15. Claims for the prizes must be made on the day. Failure to claim the prize by 21.00 on Saturday 11th May 2019 will result in disqualification and your prize will be donated to Racing Welfare.

16. Warwick Racecourse Fashion-On-The-Field prizes are non-transferable and there is no cash alternative. Warwick Racecourse reserves the right to substitute prizes of equal or greater value at any time.

17. The Competition prizes are awarded at the discretion of Warwick Racecourse's independent panel of judges and no prizes will be awarded as a result of improper actions by or on behalf of any entrant.

18. Prize winners shall not, under any circumstances whatsoever, sell or transfer their prize to any other person(s) within six months of Saturday 11th May 2019. Selling or transferring prizes includes, but is not limited to, selling and/or distributing on any website including any auction site whether it is operated by a third party or by a prize winner. Should the prize winner sell or attempt to sell any prize within six months, the prize winner agrees to repay the full market value of the prize to Warwick Racecourse who will in turn transfer funds to Racing Welfare.

19. Your Warwick Racecourse Fashions-On-The-Field Competition entry and any information submitted by you must be personal to and relate specifically to you. You hereby warrant that your entry and all information which you submit and/or distribute will not infringe the intellectual property, privacy or any other rights of any third party, and will not contain anything which is libellous, defamatory, obscene, indecent, harassing or threatening. If relevant, Warwick Racecourse reserves the right, but not the obligation, to screen, filter and/or monitor information provided by you and to edit, refuse to distribute or remove the same.

Warwick Racecourse cannot accept any responsibility for any damage, loss, injury or disappointment suffered by any entrant entering the Fashions-On-The-Field Competition or as a result of accepting any prize. Warwick Racecourse is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, or providers, computer equipment or software, failure of any email or entry to be received on account of technical problems or traffic congestion on the Internet, telephone lines or at any web site, or any combination thereof, including any injury or damage to entrant's or any other person's computer or mobile telephone related to or resulting from participation in the Competition.
