

## WINCANTON AFTERNOON RACING 5<sup>TH</sup> MARCH PRIZE DRAW - TERMS AND CONDITIONS

1. By entering the competition to win two Club enclosure tickets to Day Four of The Festival™ presented by Magners at Wincanton Racecourse (the “Prize Draw”), the terms and conditions (as defined below), entrants agree to be bound by these Rules and your attention is specifically drawn to the conditions No. 9, No.10 and No. 11.
2. In the event of any dispute regarding the Rules, conduct, results and all other matters relating to the Prize Draw, the decision of Wincanton Racecourse shall be final and no correspondence or discussion shall be entered into.
3. The Prize Draw is open to those aged 18 and over. Wincanton Racecourse assumes that by reading the publication or by using the website and entering the Competition (and you warrant that) you are aged 18 or over.
4. Employees of Wincanton Racecourse or any associated company of Wincanton Racecourse and their immediate families, persons connected with the Prize Draw i.e. prize sponsors, newsagents, wholesalers & their agents are not able to enter the Prize Draw.
5. By entering the Prize Draw, you hereby warrant that all information submitted by you is true, current and complete. Wincanton Racecourse reserves the right to verify the eligibility of all entrants.
6. Wincanton Racecourse reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of the Rules.
7. Only one entry per person per Prize Draw is allowed, any entrant who enters more than the permitted maximum will be disqualified.
8. Where the winner has been selected and Wincanton Racecourse discovers or has reasonable grounds to believe the winner has made more than one Entry, Wincanton Racecourse reserves the right to select an alternative winner.
9. To enter the Prize Draw, users must book a Wincanton Racecourse Afternoon Racing ticket for the 5<sup>th</sup> March 2020, before 11:59pm on 4<sup>th</sup> March 2020.
10. Entries to the Prize Draw will be open from 11:00am 1<sup>st</sup> January 2020.
11. Entries to the Prize Draw must be made by purchasing a ticket prior to the closing time of 11:59pm on 4<sup>th</sup> March 2020. Failure to do so will disqualify the entry.

13. Prize winners will be announced at the race meeting on 5<sup>th</sup> March 2020.
14. The winner will be randomly selected using <https://admin.woobox.com/> on 5<sup>th</sup> March 2020.
15. Claims for prizes must be made on the day. Failure to claim a prize by 5:00pm on 5<sup>th</sup> March 2020 will result in disqualification.
16. Prize Draw prizes are non-transferable and there is no cash alternative. Wincanton Racecourse reserves the right to substitute prizes of equal or greater value at any time.
17. The Prize Draw is awarded at the discretion of Wincanton Racecourse and no prizes will be awarded as a result of improper actions by or on behalf of any entrant.
18. Prize winners shall not, under any circumstances whatsoever, sell or transfer their prize to any other person(s). Selling or transferring prizes includes, but is not limited to, selling and/or distributing on any website including any auction site whether it is operated by a third party or by a prize winner. If relevant, Wincanton Racecourse reserves the right, but not the obligation, to screen, filter and/or monitor information provided by you and to edit, refuse to distribute or remove the same.

20. Wincanton Racecourse cannot accept any responsibility for any damage, loss, injury or disappointment suffered by any entrant entering the Prize Draw or as a result of accepting any prize. Wincanton Racecourse is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, or providers, computer equipment or software, failure of any email or entry to be received on account of technical problems or traffic congestion on the Internet, telephone lines or at any web site, or any combination thereof, including any injury or damage to entrant's or any other person's computer or mobile telephone related to or resulting from participation in the Competition. Nothing shall exclude Wincanton Racecourse's liability for death or personal injury as a result of its negligence.
