

## **THE JOCKEY CLUB**

### **THE 2021 FAN NATIONAL TERMS AND CONDITIONS**

1. By entering THE 2021 FAN NATIONAL competition (the 'Competition'), you agree to the terms and conditions (the "Rules") (as defined below) with your attention specifically drawn to the conditions 9, 10, 11 and 15.
  
2. In the event of any dispute regarding the Rules, conduct, results and all other matters relating to the Competition, the decision of The Jockey Club shall be final and no correspondence or discussion shall be entered into.
  
3. To qualify to enter the Competition you must be a resident in the United Kingdom, Republic of Ireland and/or the Isle of Man.
  
4. The Competition is open to anybody over the age of 18.
  
5. Employees of The Jockey Club or any associated company of The Jockey Club and their immediate families, persons connected with the Competition i.e. prize sponsors, newsagents, wholesalers & their agents, and members of the judging panel and their immediate families, are not able to enter the Competition.
  
6. By entering the Competition, you hereby warrant that all information submitted by you is true, current and complete. The Jockey Club reserves the right to verify the eligibility of all entrants.
  
7. By entering the Competition, you are agreeing to hear from The Jockey Club about the Competition and the prizes from partners that are involved.
  
8. The Jockey Club reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of the Rules.
  
9. Only one entry per person per Competition is allowed.
  
10. The Competition will open from 00.01am on the 25<sup>th</sup> March.

11. The Competition will close at 10:00am on the 8<sup>th</sup> April.

12. The Competition prize will be as below, there is no purchase requirement to enter the Competition, however, some prizes include their own T's&C's – please note these in addition:

- Winning horse - A high resolution image of winning horse emailed to them
- Prize Drawer winner – x2 tickets to The Radox Grand National Festival (day of your choice) 2022

13. All entrants who have signed up via the entry form will be put in to an automated random selection programme via The Jockey Club CRM platform and on Thursday 8<sup>th</sup> April following The Radox Grand National declarations will be emailed their horse selection.

14. Post The Radox Grand National race all entrants will be put in to a random number generator where the one winner will win x2 tickets to next year's Radox Grand National.

15. The Prize Draw Competition winner will be announced via email and social channels at approximately 6pm on Saturday 10<sup>th</sup> April. The competition winner will be contacted directly via e-mail to confirm details.

16. Confirmation of acceptance of the prize must be made by Friday 16 April 2021 at 12:00. Failure to claim the prize before Friday 16 April 2021 will result in disqualification and selection of an alternate winner. All reasonable efforts will be made to contact the winner before selection of an alternative winner is made.

17. The Competition Prizes are non-transferable, there is no cash alternative and travel and expenses to and from the race meeting will not be covered. The Jockey Club reserves the right to substitute prizes of equal or greater value at any time.

18. Competition Prizes are awarded at the discretion of The Jockey Club and no prizes will be awarded as a result of improper actions by or on behalf of any entrant.

19. Prize winners shall not, under any circumstances whatsoever, sell or transfer their Competition prize to any other person(s) for a reasonable period after the competition. Selling or transferring prizes includes, but is not limited to, selling and/or distributing on any website including any auction site whether it is operated by a third party or by a prize winner.

20. Your Competition entry and any information submitted by you must be personal to and relate specifically to you. You hereby warrant that your entry and all information which you submit and/or distribute will not infringe the intellectual property, privacy or any other rights of any third party,

and will not contain anything which is libellous, defamatory, obscene, indecent, harassing or threatening. If relevant, the Jockey Club reserves the right, but not the obligation, to screen, filter and/or monitor information provided by you and to edit, refuse to distribute or remove the same.

24. The Competition and Rules will be governed by English law and any disputes will be subject to the exclusive jurisdiction of the courts of England.
